

## **Medicare and Medical Assistance MRI Testing**

**During the course of treatment, your physician may request that you be scheduled for an MRI in order to accurately diagnose and deliver the best treatment option.**

**Since TCO owns several MRIs and to ensure that TCO is in compliance with Federal Regulations, this document lists MRI facilities that are available in the metropolitan region. You have the right to choose a different facility than the physician-recommended facility.**

**TCO may or may not have direct knowledge about the quality of scans at non-TCO facilities. It is your responsibility to confirm that the MRI facility is contracted with your health plan. If your TCO physician participates with your health plan, any MRI performed at a TCO-affiliated facility is in-network.**
