

Medicare & Medical Assistance Patients - MRI Testing

During the course of treatment, your physician may request that you be scheduled for an MRI in order to accurately diagnose and deliver the best treatment option.

Since TCO owns several MRIs and to ensure that TCO is in compliance with Federal Regulations, the reverse side/page 2 of this form lists MRI facilities that are available in the metropolitan region. You have the right to choose a different facility than the physician recommended facility.

TCO may or may not have direct knowledge about the quality of scans at non-TCO facilities. It is your responsibility to confirm that the MRI facility is contracted with your healthplan. If your TCO physician participates with your healthplan, any MRI performed at a TCO affiliated facility is in-network.
